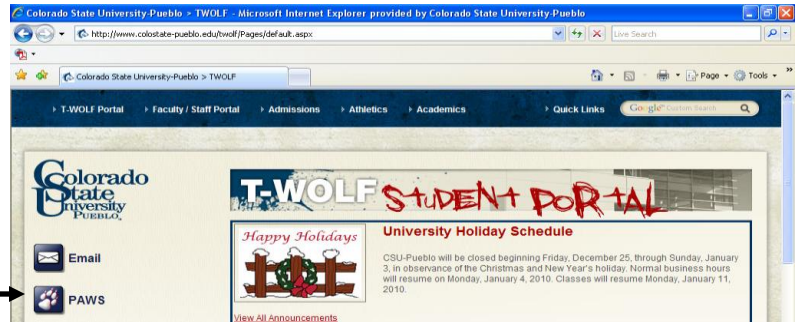


Begin here at the CSU-Pueblo homepage:

 (under CSU-Pueblo logo).

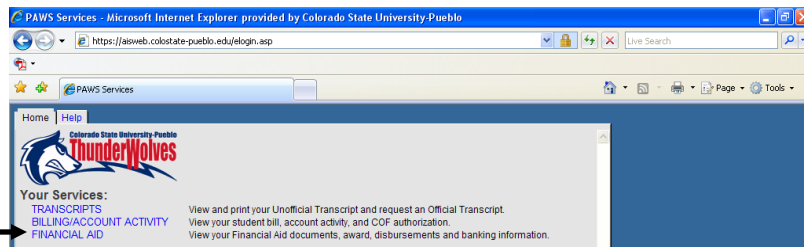


Enter your PID number and your PIN.

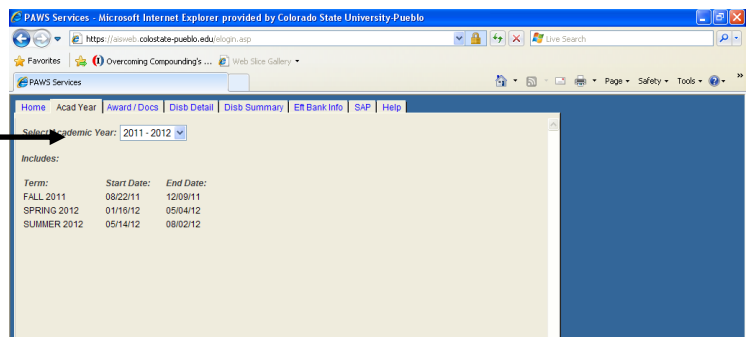


Once logged on, select "Financial
